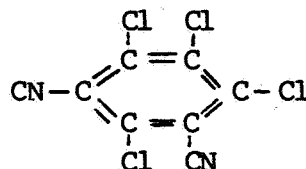

1.0 INTRODUCTION

The registrant (Diamond Shamrock) has requested that the BRAVO™500 label (Reg. # 677-313) be amended to include use on almonds, rice and wheat.

3.0 DIRECTIONS FOR USE

Proposed supplemental labelling is appended to this review.

BRAVO™500 is currently registered, as follows...

Tree and Orchard Crops (peach, nectarine, apricot, cherry, plum, prune), Conifers, Field Crops (onion, peanuts, sugarbeets (for seed), tomatoes), and Forestry/Nursery/Greenhouse Management (24c in Oregon and Washington). A copy of the current label is appended to this review.

4.0 DISCUSSION

No new data were submitted. A review of the files indicates that two studies are outstanding: leaching and anaerobic soil metabolism. The previously submitted/reviewed anaerobic soil metabolism study (4/27/76) was found deficient and must be redone.

5.0 CONCLUSION

In-house data are not adequate to support the proposed additional uses.

6.0 RECOMMENDATION

The registrant should be informed that the data gaps noted in 4.0 above must be filled prior to EAB concurrence with the proposed label amendments.
