EEB has reviewed the List A DCI package for Metribuzin. There are no changes from the inventory conducted last year. However, a clarification of one of the data requirements listed in the inventory needs to be made. The acute avian dietary study with the mallard duck is still outstanding. The dietary study with the bobwhite quail has been fulfilled. The fish early-life stage test (72-4A) and the invertebrate life cycle test (72-4B) should be added to the DCI notice.
