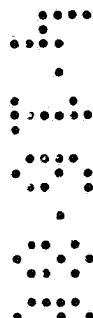

Ecological Effects Branch (EEB) finds, for the active ingredient methamidophos, there exist major data gaps critical to assessing ecological effects. These critical data gaps were detailed in EEB Memorandum to W. Miller, dated September 23, 1985. A copy is attached for your reference.

Until these data are submitted and reviewed by EEB, no full hazard evaluation is possible. Therefore, EEB does not concur with this registration request. Further, EEB will not be able to evaluate or concur on any future registration request until the identified data gaps are filled.

EEB requests that it be informed of your disposition of this matter.

EEB also requests that you inform it of your handling of the amendment to the Registration Standard.
