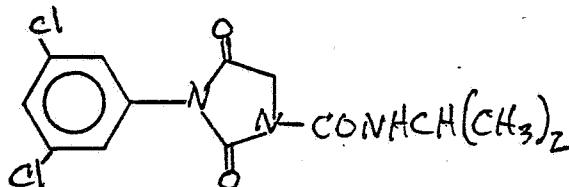

Trade Name: Rovral (also chipco 26019, Glycophene 26019, RP 26019).

Rhone-Poulenc is applying to amend the Rovral label to add onions. Rovral is currently registered for use on stone fruits (apricots, cherries, nectarines, peaches, plums, and prunes) and almonds.
