The petitioner, BASF Wyandotte Corporation, has submitted this amendment (3/27/85) in response to RCB's 3/6/84 review of amendment (2/9/84) to PP#2F2650. In that review, RCB stated that the petitioner would need to submit a food additive tolerance for 75 ppm vinclozolin residues in dried prunes. The petitioner has submitted a revised Section F in which he is proposing a 75 ppm vinclozolin tolerance for dried prunes.

RCB'S COMMENTS/CONCLUSION

RCB concludes that this proposal for the establishment of a 75 ppm food additive tolerance for vinclozolin residues in dried prunes has been properly submitted. Thus, this deficiency has been resolved.

RECOMMENDATION

TOX and EAB considerations permitting, RCB recommends for the establishment of a 75 ppm food additive tolerance for vinclozolin residues in dried prunes. In its 3/6/84 review of amendment (2/9/84) to PP#2F2650, RCB recommended for the establishment of a 25 ppm vinclozolin tolerance on stone fruits. Thus, all of RCB's requirements associated with these petitions PP#2F2650/FAP#5H5462 have been resolved.

OTHER CONSIDERATIONS

There are no Canadian, Mexican or Codex tolerances for vinclozolin in or on dried prunes. Therefore, there are no problems of compatibility of tolerances.
