1.0 INTRODUCTION

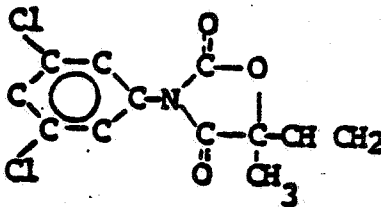
