Union Carbide Agricultural Products Company, Inc., Research Triangle Park, NC has submitted revised product chemistry for technical thiodicarb, the active ingredient in its insecticide Larvin®. The new product chemistry is a result of changes in the manufacturing process based upon the experience of commercial production. The product chemistry that was originally submitted for the registration of thiodicarb was developed from pilot plant studies. We will compare the manufacturing process and product chemistry for thiodicarb as given in Union Carbide's prior submissions with those of the currently produced technical material. Conclusion

We have compared the manufacturing process and product chemistry for thiodicarb made by Union Carbide's current procedure with those of the previously registered technical material.

We conclude that there are no substantial differences between the two technical materials.
