SUBJECT: Estimated Worker Exposure For Proposed Uses

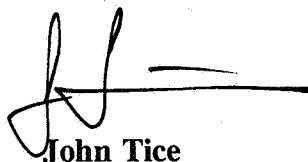

The attached documents in addition to PHED were used to estimate applicator exposure for the deliberations of the ADI committee. The exposure is based on the following information and assumptions:

- The product was applied at the rate of 0.125 lbs ai per acre by air blast equipment, open cab, open pour mixing and loading,
- handlers wear goggles, mid-forearm to elbow-length chemical resistant gloves, hat, long-sleeved shirt and long pants when mixing, loading and applying this product,
- daily exposure assumes 20 acres are treated per day at the maximum rate.

The three proposed labels and a table of estimated exposures are attached.
