FOR PEST CONTROL OPERATORS: One gallon (3.79 L) of product is sufficient to treat 1500 linear feet (457 m) with a 6 inch (15.2 cm) spray band.

For contact and residual sprays, use this product without diluting. For spot treatments, dilute with equal parts of water.

CONTACT SPRAY - KILLS AND REDUCES INFESTATIONS: Cockroaches (waterbugs), crickets, silverfish (firebrats), clover mites, centipedes, millipedes, earwigs, sowbugs (pillbugs), spiders, brown dog ticks, lone star ticks, ants, fire ants, carpet beetles, earwigs, boxelder bug, scorpions, spider beetles, bed bugs, confused flour beetles, sawtoothed grain beetles, shiny spider beetles, grain mites, red flour beetles, angoumois grain moths, lesser grain borers, cigarette beetles, drug store beetles, chocolate moths. Use as a spot treatment. Where possible, spray directly on

pests to reduce infestations. Apply as a coarse spray or with a paint brush into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators and other appliances, baseboards and storage areas. Apply spray until area is wet, but not to the point of run-off. Repeat as necessary.

ANTS (Including Fire Ants): To kill ants, spray trails, nests and points of entry within buildings and homes. Spray directly on ants where possible. Repeat as necessary.

FLEAS, BROWN DOG AND LONE STAR TICKS: Thoroughly apply as a spot treatment to infested areas such as pets' beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas. **DO NOT TREAT PETS WITH THIS PRODUCT.** Treat pets with a product registered for animal application such as SBP-1392e/Bioallethrin Aqueous Pressurized Spray, EPA Reg. No. 432-482, to control the source of flea and tick infestation.

CARPET BEETLES AND CLOTHES MOTHS: Do not spray clothing with this product. Do not allow clothing to contact areas where this product has been used. Spray edges of carpeting and under carpeting, rugs, and closets. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets, and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

RESIDUAL SPRAY: AIDS IN THE CONTROL OF COCKROACHES (Waterbugs), CRICKETS, BOXELDER BUGS, SCORPIONS, SPIDER BEETLES, SILVERFISH (Firebrats), CENTIPEDES, MILLIPEDES, EARWIGS, SOWBUGS (Pillbugs). Kills up to 4 weeks. Apply on baseboards, cracks and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. In basements, apply in hiding places, in cracks and crevices, lower walls and dark places. Spray surfaces until wet, but not to the point of run-off.

PESTS OUT-OF-DOORS

DO NOT TREAT OR ALLOW THE SPRAY TO CONTACT PLANTS (LAWNS, FLOWERING PLANTS, SHRUBS, TREES, EVERGREENS, ETC.) BECAUSE OF POSSIBLE INJURY.

PESTS ON OUTSIDE SURFACES OF BUILDINGS: Use this product to control ants, clover mites, crickets, earwigs, millipedes, and sowbugs (pillbugs), on outside surfaces of buildings. To help prevent infestation of buildings treat the building foundation to a height of 2 to 3 feet (.65 to 1 m), where pests are active and may find entrances. Also, apply as a residual spray to outside surfaces of buildings, including porches, screens, window frames, eaves, patios, garages, refuse dumps, and other areas where these pests congregate or have been seen. Repeat treatment as needed to maintain effectiveness.

HOUSE FLIES, MOSQUITOES, GNATS, FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

ANTS, BROWN DOG TICKS, CRICKETS, FLEAS, AND EARWIGS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat application as infestations warrant and as reinfestations occur.

TO CONTROL FIRE ANTS: Dilute 1.5 pints (0.71 L) of this product in 1 gallon (3.79 L) of water. Apply 1 gallon (3.79 L) of solution as a gentle rain to each fire ant mound using a sprinkler can. Thoroughly wet the mound and surrounding area to a 4 foot diameter (1.22 m). For best results, apply in cool weather, 65-90°F (18.5-27°C), or in early morning or late evening hours. Treat new mounds as they appear. Do not disturb the mound prior to treatment. If possible, treat all mounds in the vicinity, and treat all colonies which may not as yet have constructed a mound. Larger quantities of solution can be prepared for multiple mound treatments. Equipment to deliver the diluted product as a gentle rain at the rate of 1 gallon (3.79 L) per mound is still required. Do not use equipment that generates a pressurized spray as pressurized sprays may disturb fire ants and cause migration, reducing product effectiveness.
