The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Boric Acid Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

A copy of your label stamped "Accepted" is enclosed. Products shipped after 12 months from the date of this amendment must bear the new revised label. Your release for shipment of the product bearing the amended label constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product may be used in homes, restaurants, markets, schools, warehouses, factories, offices, hotels, motels, hospitals, nursing homes, garages, grocery stores, apartment buildings, new construction, industrial plants, theaters, ships, boats, trains, trucks, yachts, camps, mobile homes, buses, zoos, kennels, military bases, libraries, utilities and sewers.

**Use Restrictions:** Apply only in areas inaccessible to children and pets. Avoid contamination of feed and foodstuff. Do not use in edible product areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

#### **DOMESTIC USE**

{The following direction will be used for product sold in the "puffer" container and 2 lb bag with duster included:}

Shake well before opening. Using the easy applicator, create a barrier through which cockroaches and other insects must crawl.

{The following direction will be used for product not sold in the "puffer" container :}

Shake well before opening. Apply with a teaspoon to create a barrier through which cockroaches and other insects must crawl. Do not use food utensils such as teaspoons and measuring cups for food purposes after use with insecticides.

Apply liberally under and behind refrigerator, stove, sink, dishwasher, washing machine, dryer and tubs in kitchen and utility rooms. Apply in cracks and crevices along baseboards and corners of cabinets, cupboards and closets. Apply a line from corner to corner in rear of kitchen cabinets or drill ½" holes at top of kick panels beneath cabinets in kitchens and bathrooms, dusting liberally. Remove lower drawers in kitchen and bathroom cabinets, bedroom dressers and chests of drawers and liberally dust into drawer wells and under bookshelves. Apply into openings and void areas around plumbing, drains, water pipes and electrical conduits. Any powder visible after application may be brushed into cracks and crevices or removed. Reapply as necessary.

#### NON-DOMESTIC USE (Only Non-Edible Product Areas)

Application in New and Existing Construction to control roaches and other insects: When treating large areas, such as voids, soffits and subcabinet voids, dust liberally. Dust into pits of dumbwaiters, elevator shafts and trash chutes. In storerooms, dust under pallets and behind boxes.

This container is sold by weight, NOT by volume. You can be assured of the proper weight even though some settling of contents normally occurs during transportation and handling.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store only in original container, in a dry place inaccessible to children and pets.
