Dear Ms. Horton;

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

 Within the Optional Marketing Statement Section, the following Claim "Environmental Formula - Contains no Fluorocarbons" must be revised in accordance with PR Notice 92-2. Permissible Label Claims Regarding Ozone Depleting Substances. A copy of the PR Notice is enclosed.

"Statements concerning the absence of ozone-depleting chemicals may be made on pesticide labeling provided that the product does not contain either Class I or Class II ozone-depleting chemicals and that the statement does not broadly imply that the product is safe for humans or the environment. Further, any registrant wishing to make specifically a CFC-related claim for its product must add an additional label statement that federal regulations prohibit CFC propellants in aerosols. Such a statement is necessary so that consumers are not mislead to believe that pesticide products still contain CFC propellants.

The following statement, if used exactly, may be added to the labeling of aerosol pesticide products by notification to the Agency in accordance with 40 CFR 152.46(a)(1) and PR Notice 88-06. Alternative statements concerning protection of the ozone layer must be approved by the Agency through the normal amendment process.

**Disposal:** We empty – Do not reuse this container. Place in trash or offer for recycling if available. If partly filled – Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.

Prior to spray application, remove infested plants from living and eating areas, and place in an area not likely to come in contact with pets, children or food. Plants can be returned to original location when leaves dry.

If plant removal is not possible, remove or cover exposed food and food handling surfaces, including utensils, and remove animals. Shut off ventilating system, air ducts, and air conditioning equipment. Avoid spray contact with surrounding areas.

Swirl or shake gently before use. EPA Reg. No. 4-312 7/2/03 – amendment

This product may be used for control of aphids, fungus gnats, leafhoppers, mealybugs, plant bugs, spider mites, spittlebugs, thrips, and whiteflies in greenhouses, lathhouses, homes, commercial and institutional buildings, and for indoor landscaping.

Apply the spray to the upper and lower surfaces of plant foliage to the point of run-off. Avoid wetting blossoms if possible. For best results, spray in the late afternoon or evening when temperatures are lower and plants are not in direct sunlight. Repeat applications weekly if necessary. Use on the following ornamental plants:


