

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors or spray mist, and provide adequate ventilation of area being treated. Contact with the eyes, skin or clothing should be avoided.

ENVIRONMENTAL HAZARDS

This pesticide is highly toxic to fish. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area. Drift and runoff form treated sites may be hazardous to fish in adjacent waters. Consult your State's Fish and Wildlife Agency before treating around such waters.

PHYSICAL OR CHEMICAL HAZARDS

STORAGE AND DISPOSAL



STORAGE: Store in a cool dry area inaccessible to children or pets. Store and transport in upright position.

DISPOSAL: If empty: Nonrefillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

Avoid contamination of feed and foodstuffs. Food should be removed or covered in such a way as to prevent contamination during treatment. Do not apply while food processing plant is in operation. Food contact surfaces and equipment must be washed with an effective cleaning compound followed by a potable water rinse after treatment. Facilities and equipment in federally inspected meat and poultry plants must be washed with an effective cleaning compound followed by a potable water rinse after treatment. In hospitals, patients should be removed from room prior to treatment. Room should be ventilated for two hours after spraying. Do not return patients to room until after ventilation. Remove pets, birds, and cover fish aquariums before spraying. DO NOT ALLOW CHILDREN IN TREATED AREAS UNTIL SURFACES ARE DRY.

For use outdoors in yards, patios, picnic areas, drive-ins, around swimming pools, poultry houses. For use indoors and outside premises of hotels, motels, homes, food handling establishments, packaging and processing plants, seed houses, commercial, industrial, office, institutional and storage buildings, milk handling areas of milk plants, milk storage rooms, egg processing plants, supermarkets, restaurants, bottling plants, canneries, flour and feed mills, bakeries, boats, ship cabins, and hospitals. Also for use in buses, automobiles, trucks, boxcars, ship cargo holds, and in dog kennels and horse stables. IN HORSE STABLES, NOT FOR APPLICATION IF HORSES WILL BE USED FOR FOOD.

Before using this pesticide, exposed food and packaging material must be removed or protected. After using pesticide, food processing and handling equipment and utensils must be washed with an effective cleaning compound and thoroughly rinsed with potable water before operations are resumed.

OUTDOORS

Thermal Applications – This formulation is to be used undiluted in only such portable thermal applicator equipment that can deliver spray particle sizes within the aerosol-size range. For reduction in annoyance from flies, mosquitoes and gnats in yards, patios, around swimming pools, picnic areas, drive-ins, and horse stables. Hold thermal applicator at least five feet from any object, especially plants and shrubbery. Avoid wetting any plant foliage. Apply undiluted at the rate of 3 ¾ gallons per acre (32 ozs. per 2,900 sq. ft.). Fog only when there is no breeze, or the wind velocity is less than 3 miles per hour. The ideal time is generally at dusk when the wind dies down and the air temperature and ground temperature are approximately the same. Under these conditions the fog will linger in the treated area for a longer time. Apply fog while moving away from treated area. Avoid inhalation of the fog. Do not enter the treated area until the fog has dissipated. Repeat application as necessary.

- For reduction in annoyance from house flies, mosquitoes, gnat, fleas, ticks and blackflies in yards, patios, around swimming pools, picnic areas, drive-ins, and horse stables, and other small area applications. Hold thermal applicator at least 5 ft. (1.5 m) from any object, especially plants and shrubbery. Avoid wetting any plant foliage. Apply undiluted at the rate of 3^{-3} gals. per 3,800 sq. ft. Fog only when there is no breeze, or the wind velocity is less than 3, mph (5 kph). The ideal time is generally at dusk when wind dies down and the air temperature.

EPA Reg. No. 4-337 6/26/09 – Notification EPA Est. No. 4 NX-1 Page 3 of 5 Pages and ground temperature are approximately the same. Under these conditions the fog will linger in the treated area for a longer time. Apply fog while moving away from the treated area. Avoid inhalation of the fog. Do not enter the treated area until the fog has dissipated. Repeat application as necessary.

NOTE: Treat dogs and cats with a registered flea/tick control product before they re-enter the treated area.

Contact Spray – To kill nuisance pests around buildings, patios and paved areas: Spray directly on insects. Avoid spraying turf or plants.

ANTS: Same as directed for indoor application.

WASPS, HORNETS, YELLOW JACKETS: Application should be made in late evening when insects area at rest. Point spray opening away from face. Aim spay at nest opening in bushes, under eaves, chimneys, cracks and crevices. Thoroughly saturate nest with spray, contacting as many insects as possible. Spray liberally into hiding and breeding places.

EARWIGS, SOWBUGS, SPIDERS, CENTIPEDES and MILLIPEDES: Apply as a contact spray, as for indoor use.

To control flies, mosquitoes and gnats and crawling insects around premises, spray thoroughly around doors, window frames and similar areas of entry. Also thoroughly spray garbage and refuse areas, especially around poultry houses, barns, and similar areas of heavy infestation. Do not spray on turf or plants.

INDOORS

Thermal Applications – For use undiluted in electric, propane, or gas-powered thermo-foggers and such portable thermal applicator equipment that can deliver spray particle sizes within the aerosol-size range.

To kill house flies, mosquitoes, gnats, fruit flies, flying moths (millers): remove or cover exposed food and food handling surfaces. Remove animals, fish and plants. Shut off ventilating systems, air ducts, air conditioning equipment and close off room or area to be treated. Do not apply while food processing plant is occupied or in operation. Extinguish all flames and pilot lights. APPLY AS A DRY FOG AT THE RATE OF 1-1/3 fluid ounces per 1,000 cubic feet of space. Direct nozzle of thermal applicator toward the upper corners of the room and along the ceiling. Close off room for at least one-half hour. Do not remain in treated areas. Ventilate the area after treatment.

Space Spray – To kill house flies, mosquitoes, gnats, fruit flies, flying moths (millers): Close off room or area to be treated. Shut off air-conditioner and ventilator system: Seal all open vents. Remove animals and plant life. Cover or remove fish aquariums. Apply undiluted as a very fine mist space spray through manually operated equipment or with electric or other powered applicators. Avoid staining by holding the spray nozzle at least five feet from objects. Direct the fine spray at the rate of 5 fluid ounces per 5,000 cubic feet. Leave room closed for one-half hour. Ventilate thoroughly before re-entry. Sweep up and destroy insects.

Contact Spray – To kill cockroaches, waterbugs, ants, crickets, silverfish, earwigs, spiders, grain mites, Sowbugs, centipedes and millipedes. Adjust spray to produce large wetting-type spray particles. Direct spray to contact these insects in cracks and crevices in floors, baseboards, around pipes, behind cabinets and other harborages. Spray these infested areas until thoroughly, wet. Repeat as necessary.

TO KILL ANTS: Spray around doors and window frames, ant trails, and hills in addition to direct spray to contact insects.

 $\frac{\partial}{\partial t}$ TO KILL SPIDERS: Spray directly on these pests and use repeated applications to the webbing and all cracks and crevices which harbor spiders.
