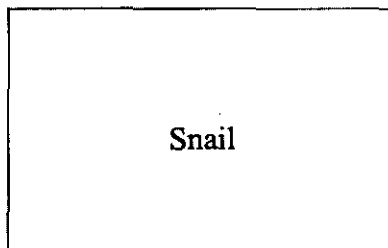
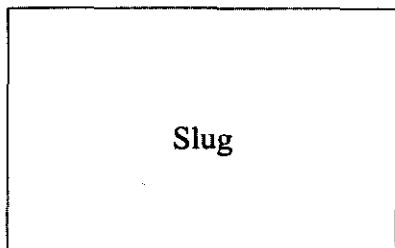

FIRST AID

WARNING: Keep out of reach of children. May be fatal if swallowed or inhaled. Avoid breathing spray mist. Avoid contact with skin, eyes or clothing. Do not allow the bait to contact the edible portion of any food or feed crop. Wash thoroughly after using.

STORAGE AND DISPOSAL
<p>Storage: Store and transport in an upright position. Store in a cool dry area inaccessible to children or pets.</p> <p>Disposal: <i>If empty</i> – Do not reuse this container. NOTE: Shake vigorously before each use.

FLOWERS, LAWNS, ORNAMENTAL GARDENS: Ajuga, Begonia, Coleus, Dahlias, Daisies, Geraniums, Iris, Marigold, Pansies, Petunias, Primroses, Salvia, and Dichondra. Apply a line of drops to the soil around areas or individual plants to be protected. Allow no more than three inches between each drop. For best results, apply in the evening, as slugs and snails feed mostly at night. Repeat application as needed.

VEGETABLES, FRUIT: Beans, Broccoli, Cabbage, Carrots, Cauliflower, Corn, Cucumber, Eggplant, Lettuce, Onions, Peas, Peppers, Potatoes, Pumpkins, Radishes, Rhubarb, Spinach, Squash, Tomatoes. Apples, Blueberries, Cantaloupe, Cherries, Grapes, Peaches, Pears, Raspberries, Strawberries. Apply a line of drops to the soil around plants to be protected. Allow no more than three inches between each drop. Do not apply Slug and Snail Beater directly to the plants.
