HAZARDS TO HUMANS AND DOMESTIC ANIMALS

WARNING: Keep out of reach of children. May be fatal if swallowed or inhaled. Avoid breathing spray mist. Avoid contact with skin, eyes or clothing. Do not allow the bait to contact the edible portion of any food or feed crop. Wash thoroughly after using.

This pesticide may be fatal to children and dogs or other pets if eaten. Keep out of reach of children and pets, poultry and livestock. Protect dogs from treated areas since they may be attracted to this product when applied. Do not allow children and pets to play on treated areas until residues have been washed off and into the soil.

STATEMENT OF PRACTICAL TREATMENT

If swallowed, call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. **ANTIDOTE:** Artificial respiration; keep chest and lower extremities warm. Digitalis hypodermically; 10 gr. calcium glucomate intravenously.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to birds and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams, or ponds. Do not apply when weather conditions favor drift from treated areas. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes). Do not contaminate water when disposing of equipment washwaters.

DIRECTIONS FOR USE

Vegetables: Beans, Broccoli, Cabbage, Carrots, Cauliflower,
Corn, Cucumber, Egg Plant, Lettuce, Onions, Peas, Peppers,
Potatoes, Pumpkins, Radishes, Rhubarb, Spinach, Squash, Tomatoes.
Mix 2 oz. per gal. of water and apply to 100 sq. ft. around listed
vegetables. Do not allow the spray to contact vegetables.
SPRINKLING CAN

Mix 2 ounces (4 tablespoons) per gallon of water. Apply to 100
sq. ft.

HOSE-END SPRAYER

Use 2 ounces (4 tablespoons) for each gallon of water delivered
by your sprayer. Apply one gallon of this mix to 100 sq. ft.

For complete control, cover entire area. Bonide Slug-N-Snail
Beater should be applied in the evening as slugs feed mostly at
night. Re-apply after two weeks or after heavy rain.
