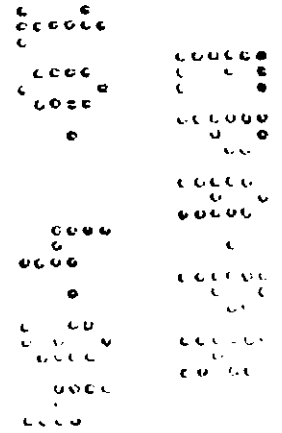

APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.

SERVING AREAS: Facilities where foods are served such as dining rooms, but excluding areas where foods may be prepared or held, apply as a spot treatment to selective surfaces, such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)

DIRECTIONS FOR HOUSEHOLD AND OUTDOOR USE IN NON-FOOD AREAS: Including garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling). Brown Dog Ticks: Apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these insects may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas. Additionally, treat pets with an E.P.A. approved product registered for direct application to pets.

Flies and Mosquitoes: Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eavos, porches, partitions and in garages where these insects may congregate. 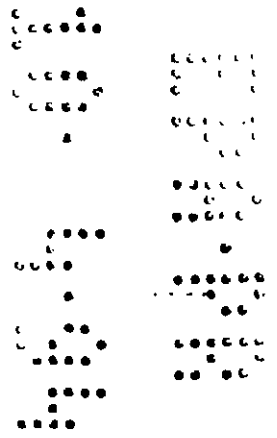
To control Cockroaches, Ants, Earwigs, Waterbugs, Silverfish, Spiders and Crickets apply in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream of insecticide, in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, in conduits, motor housings, junction or switch boxes, prior to application de-energize electrical equipment. After application allow time for oil to evaporate before starting motors or placing switches in "ON" position. Care should be taken to avoid depositing the product

onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.
