On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

- 1. Submit and/or cite all data required for registration/ reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
 - 2. Make the following label changes:
 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 4-370".
 - b. Separate the warranty language ("Buyer assumes all risks...") from the "Environmental Hazards" section.

c. Revise the "Hazards to Domestic Animals" section so that it reads: "Harmful if absorbed through the skin or inhaled. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling. Wash exposed clothing before reuse. Do not contaminate feed, water or foodstuffs. Cover fish aquariums before use."

Note, the language corresponding to precautions regarding exposure of the product to the eyes or oral ingestion in this section of the proposed labeling is not mandatory. However, the Agency will permit these statements to be retained on the final label at your discretion.

d. Revise the "Statement of Practical Treatment" section so that it reads, "If on skin: Wash with plenty of soap and water. Get medical attention if irritation persists. If inhaled: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention."

Note, the language corresponding to the "if swallowed" and "if in eyes" warnings contained on the proposed label are not mandatory. However, the Agency will permit these statements to be retained on the final label at your discretion.

- e. Add the following to the "Directions for Use" section, "Keep people and pets off treated carpet and upholstered furniture during treatment and until area is vacuumed."
- f. Given the confidential statement of formula, the Agency questions whether the statements, "with deodorizer" and ""Pleasant fragrance freshens carpets" are supportable. These should be removed.
- 3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.

For use on carpets, hold upside down and shake powder evenly across surface. Brush lightly with a broom to allow powder to penetrate carpet libers. Walt 60 minutes, then vacuum. For severe problems or where ticks are known to be hiding, wait 2-3 hours before vacuuming. If powder adheres to a spot, brush it out and vacuum immediately. Apply to dry surfaces only. Do not allow powder to become wet. For use on uphoistery, remove all loose cushions. Sprinkle along creases, in corners. Brush gently, wait 60 minutes, vacuum. Sprinkle along underside of furniture. Do not use on exposed fabric; may cause staining. Remove bag from vacuum cleaner. Wrap securely in several layers of newspaper and discard in trash.

*Test hidden surface or uphoistery before cleaning. If texture or color is affected, do not use.

Clean carpet AFTER using this product.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Store in original container in an area inaccessible to children and pets and away from heat and sunlight.
