DIRECTIONS FOR USE (cont.):

Use Restrictions:

RABBITS AND TREE SQUIRRELS: Shotgun Animal Repellent Concentrate repels rabbits and tree squirrels from fruits and vegetables including: citrus fruits, root and tuber vegetables, bulb vegetables, leafy vegetables, brassica (cole) leafy vegetables, legume vegetables, fruiting vegetables, and cucurbit vegetables; and from wooden structures and fences. Shotgun Animal Repellent Concentrate can also be used on all indoor and outdoor ornamental plants.

ALL USES: Apply Shotgun Animal Repellent Concentrate using spray equipment. Do not apply this product through any type of irrigation system.

Mixing, Application, and Retreatment Directions for Plants: Apply Shotgun Animal Repellent Concentrate as diluted below, as a foliar spray to the leaves, stems, fruits, and flowers of the plant until wet. Do not drench roots in soil or media. Do not apply when rain is expected within 24 hours.

IF TREATMENT AREA IS LESS THAN 1 ACRE: INITIAL rate is 1 part Shotgun Animal Repellent Concentrate to 16 parts WATER (8 oz. or 16 Tbs. per gallon of water). Apply until foliage is wet or a maximum of 3 gallons prepared solution per 1000 square feet. Repeat application in 3-7 days, for 2-3 weeks, until control is established. ONCE CONTROL IS ESTABLISHED use MAINTENANCE rate of 1 part Shotgun Animal Repellent Concentrate to 32 parts WATER (4 oz. or 8 Tbs. per gallon of water) every 2-4 weeks, as necessary to maintain control.

IF TREATMENT AREA IS 1 ACRE OR MORE: INITIAL rate is a maximum of 6 gallons Shotgun Animal Repellent Concentrate to a minimum 100 gallons WATER per acre. Apply until foliage is wet. Repeat application, if necessary, in 1 to 2 weeks, until control is established. ONCE CONTROL IS ESTABLISHED use MAINTENANCE rate of 2 gallons Shotgun Animal Repellent Concentrate to a minimum 100 gallons WATER per acre, every 2-4 weeks, as necessary to maintain control.

Mixing, Application, and Retreatment Directions for Wooden Structures and Fences: Mix 8 ounces (16 Tbs.) per gallon of water. Apply until surface is wet. Repeat application, if necessary, in 1 to 2 weeks, until control is established. Once control is established, apply every 6 to 8 weeks to previously sprayed surfaces.
