

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC
ANIMALS**

CAUTION: Harmful if swallowed. Avoid breathing of spray mist. Avoid contact with skin; wash hands and skin thoroughly after using. Avoid contamination of feed or foodstuffs. Keep out of reach of children. Malathion is a cholinesterase inhibitor and can cause symptoms similar to those caused by other organic phosphate compounds although much larger exposures are required. If poisoning should occur, CALL A PHYSICIAN IMMEDIATELY. ATROPINE IS ANTIDOTAL DO NOT use on Boston, Maidenhair or Pteris ferns and some species of Crassula.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish, aquatic invertebrates, and aquatic life stages of amphibians. Do not apply directly to water or wetland (i.e., swamps, bogs, marshes, and potholes). Drift and runoff may be hazardous to aquatic organisms in areas near the application site. Do not contaminate water when disposing of equipment washwaters.

This product is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area.

**STATEMENT OF PRACTICAL
TREATMENT**

IF SWALLOWED: Call a physician immediately. DO NOT INDUCE VOMITING.

IF INHALED: Remove victim to fresh air. Apply artificial respiration, if indicated.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water. See a physician if irritation persists.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

NOTE TO PHYSICIAN: This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.





HOUSEHOLD PESTS: (Roaches, Ants, Spiders, Mosquitoes, Silverfish, Crickets, Clover Mites, Earwigs): **IN AND ABOUT HOMES. Use 8 tablespoons per gallon water.** Apply by means of a coarse spray or paint brush around window frames, baseboards, under sinks, drainboards, stoves and to other limited areas where these pests congregate. **DO NOT** contaminate food or utensils. **DO NOT** use in milk processing rooms. Repeat as necessary.

Use only with adequate ventilation. After using this product indoors, ventilate thoroughly before occupying enclosed spaces. Do not allow contact with treated surface until sprays have dried.

FLEAS ON DOGS AND CATS: 2 tablespoons per gallon water. Wet thoroughly to penetrate hair. **DO NOT** apply more than once weekly. **DO NOT** treat animals under one month of age. **ANIMAL QUARTERS. 10 tablespoons per gallon water.** Spray kennels, pens, yards, lawns and under houses, at the rate of 1 gallon diluted spray per 1,000 sq. ft. Remove animals before treatment, putting in fresh bedding after treatment.

FRUITS: (Apples, Pears, Grapes) - **APHIDS** 1 1/2 to 2 teaspoons to 1 gallon water. **RED SPIDER MITES, MEALYBUGS, WHITE FLY, THRIPS, JAPANESE BEETLE ADULTS, GRAPE LEAF-HOPPERS (Not on Pears), WOOLY APPLY APHIDS, TARNISHED PLANT BUGS, PEAR PSYLLIDS (last three not to Grapes):** 1 tablespoon per gallon water. **SCALE CRAWLERS:** 1 1/2 to 2 tablespoons per gallon water. Dragon Malathion may cause injury to McIntosh and Cortland varieties of apples, to Bosc Pears and Ribier Grapes. **DO NOT** apply within 3 days of harvest on apples and grapes or within 1 day on pears.
