APPLICATION RATE

For the control of **Cabbage Looper** on Broccoli, Cabbage, Cauliflower, Kale, Mustard and Turnip Greens, Celery, Lettuce, Melons, Potatoes, Spinach, Tomatoes and Cucumbers (southeastern U.S. only), apply approximately $\frac{1}{2}$ to 1 lb./500 sq. ft.

For the control of **Imported Cabbage Worm** on Broccoli, Cabbage, Cauliflower, Collards, Kale, Mustard and Turnip Greens, apply approximately $\frac{1}{2}$ to $\frac{3}{4}$ lb./1,000 sq. ft.

For the control of **Grape Leaf Folder** on Grapes, apply approximately $\frac{1}{2}$ to 1 lb./500 sq. ft.

For the control of **Hornworm** on Tobacco, apply approximately $\frac{1}{2}$ to 1 lb./1,000 sq. ft.
