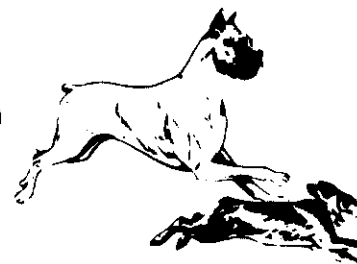
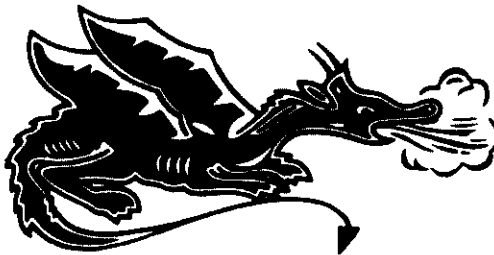

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dragon Rabbit and Dog Chaser is most effective when used before dog establishes his "territory lines" and "pattern" around the area to be treated. If this territory has been established it is important to remove all traces of previous droppings and urine before applying this product.

After the area has been prepared distribute a several inch band around ornamentals, trees and shrubs needing protection. Spread a band of two or more inches around the area to be protected. Do *not* apply directly to the plant. Repeat application every three weeks or more often if there is heavy rainfall, snow, wind or hot weather.

3 lbs. of this product will treat approximately 85 running feet.

STORAGE: Store in a cool, dry place away from feed and foodstuffs.

DISPOSAL: Do not reuse empty container. Wrap and put in trash collection.
