Our letter of July 19, 2001 (Resent October 10, 2002) Your amended application of November 1, 2002

Purpose

This submission responds to our July 19, 2001, letter requesting information about possible greenhouse crop uses of this product, which contains the active ingredient, **Nicotine**, in the form of tobacco dust. You submitted 1) a statement that the label had no greenhouse crop uses; 2) a copy of the stamped, accepted label of February 10, 1999, which contained no crop uses; 3) three (3) copies of current labeling; and 4) a Confidential Statement of Formula (CSF) dated October 22, 2002.

1. Certification statement

Your statement certifying that "... Greenhouse Uses are not Part of the Current Lableing." omitted the word, "crop" before "Uses". However, a check of your label reveals the following prohibition:

"DO NOT USE THIS PRODUCT IN VEGETABLE GARDENS NOR ON FOOD CROPS.

Further your October 31, 2002, letter states that "... the subject product does not include any uses on GreenHouse Crops." Therefore, you need not resubmit your certification.

2. Last stamped label

We received a copy of the last accepted labeling for this product, stamped February 10, 1999.

3. Copies of current label

You submitted three (3) copies of your current labeling, which is identical to your last accepted label. Because we last approved labeling for this product four years ago, we have reviewed these labels now.

The labeling submitted under the Federal Insecticide, Fungicide. and Rodenticide Act (FIFRA) is acceptable provided that you submit one (1) copy of revised, final printed label with the following changes:

1. Format and modify your "PRECAUTIONARY STATEMENTS" as follows:

PRECAUTIONARY STATEMENTS

Existing stocks Stocks of existing labels may be used for eighteen (18) months.

Consequence for non-compliance

If these conditions are not complied with, the registrations will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the products constitutes acceptance of these conditions.

4. Revised CSF

Your revised CSF of October 22, 2002, is unacceptable because you failed to include the information about the nominal concentration, upper certified limit, and lower certified limit for the active ingredient, Nicotine. Refer to your previous CSF dated January 10, 1997, for the correct presentation.

DO NOT USE THIS PRODUCT IN VEGETABLE GARDENS NOR ON FOOD CROPS. May be used around the perimeter of vegetable gardens. Do not allow the product to wind drift to nearby food

Application Directions: Before treatment, try to remove all traces of animal droppings and urine from the areas to be protected. Animals are attracted by the odors of these deposits. If the odors are effectively removed, regular use of DRAGON® Rabbit & Dog Repellent around ornamental plants, trees and shrubs should discourage new defecations by dogs and visitations by rabbits.
