This product also may be used to repel cottontail rabbits (Sylvilagus floridanus) from entering, feeding in, or defecating within treated areas associated with flower gardens, ornamental plants, trees and shrubs.

DO NOT USE THIS PRODUCT IN VEGETABLE GARDENS NOR ON FOOD CROPS. May be used around the perimeter of vegetable gardens. Do not allow the product to wind drift to nearby food crops.

Application Directions: Before treatment, try to remove all traces of animal droppings and urine from the areas to be protected. Animals are attracted by the odors of these deposits. If the odors are effectively removed, regular use of DRAGON® Rabbit & Dog
