Dear Ms. Horton:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. On page 1, in the ingredients statement, delete the footnote "Contains Xylene range aromatic solvent." (This kind of footnote is necessary only when the formulation contains more than 10% of the solvent.)
2. On page 3, in the directions for the control of wood-infesting beetles, add the following sentence: "For beams or other overhead areas, apply to wood with a paintbrush."

Submit five (5) copies of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store in cool, dry place away from feed and foodstuffs. Do not store below 32°F.

**PESTICIDE DISPOSAL:** Securely wrap original container in several layers of newspaper and discard in trash.

**CONTAINER DISPOSAL:** Do not reuse empty container. Discard container in trash.

**HOW TO USE:** *Shake well before using.* Hold container upright and spray infested surfaces until wet. Do not use as a space spray. Do not spray desirable plants. Repeat the treatment as needed. [For gallon size - **NOTE:** After each use, store nozzle above liquid level of container to prevent leakage and siphoning from nozzle.]

**INDOOR PESTS**

Do not apply sprays of this product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. Do not allow spray to contact food, feedstuffs and other water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying.

**TO CONTROL ROACHES, ANTS, CLOVER MITES, CRICKETS, FIREBRATS, SILVERFISH and SPIDERS:** Application within residential buildings including homes and apartments - **For Spot Treatment Only:** Apply as a coarse spray or with a paintbrush to localized areas where cockroaches (including strains resistant to other insecticides), ants, clover mites, crickets, firebrats, silverfish and spiders are found or normally occur, including dark corners of rooms and closets; cracks and crevices in walls; along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. For ants, apply to ant trails; also around doors and windows and wherever else these pests may find entrance. **NOTE:** A period of 4 to 7 days is normally required for maximum effect on cockroaches.

**FOR CONTROL OF CARPET BEETLES:** Thoroughly apply as a spray for spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

**FOR CONTROL OF FLEAS AND BROWN DOG TICKS:** Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames; and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. **DO NOT TREAT PETS WITH THIS PRODUCT.** To control the source of flea infestations, pets inhabiting the treated premises should be treated with a product registered for application to animals.

**FOR CONTROL OF CARPENTER ANTS:** Apply as a coarse spray around doors, windows and other points of entry; into cracks and crevices or through small, newly drilled holes into wall voids where ants or their nests are suspected.

**OUTDOOR PESTS**

**FLIES.** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, windows frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. Repeat as necessary.

**ANTS, BROWN DOG TICKS, CRICKETS, FLEAS and EARWIGS.** For the treatment of localized infestation of these insects in outdoor areas where there are weeds or brushy non-crop areas, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestation occurs.

**WOOD-INFESTING BEETLES.** (Lyctidae, Bostrichidae, Anobudae and Cerambycidae) To protect wood and control damage by these wood infesting insects, apply to wood using a coarse spray to the point of run-off.

**PRECAUTIONARY STATEMENTS**

**Hazards to Humans**

May be harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs and domestic water supplies. Wash thoroughly after handling.

**FIRST AID**

**IF SWALLOWED:** Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.
