Subject: Revised Labeling Ro-Pel® Animal Repellent EPA Registration No. 16-181 Your Submission E-mailed on November 21, 2003

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes indicated below before you release the product for shipment bearing the amended labeling:

- 1. In the Active Ingredient statement revise the name of the first active to "Denatonium Saccharide." Also, "Active Ingredients" and "Inert Ingredients" must appear in the same point size.
- 2. The acute toxicity profile for your product is toxicity category IV for all routes of exposure. Your product is a non-dermal sensitizer. Therefore, you may delete all First Aid statements. The following may also be deleted from the Hazards to Humans and Domestic Animals: "Applicators and handlers must wear.....face shield)."

3. Delete "For best results" from the phrase, "For best results.....following methods."

Please note that there may still be outstanding efficacy data requirements for this product associated with the thymol RED. We are currently reviewing the requirements and may request efficacy data in the near future. Submit two copies of your final printed labeling before you release the product for shipment.
