FOOD HANDLING ESTABLISHMENTS - Places other than private residences in which exposed food is held, processed, prepared or served.

FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY.

lectudes areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) and cerving areas (when food is exposed and facility is in operation).

To control roaches, ants, waterbugs, silverfish, spiders and crickets apply in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream of insecticide, in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, in conduits, motor housings, junction or switch boxes. SERVING AREAS --- Facilities where foods are served such as dining rooms, but excluding areas where foods may be prepared or held, apply as a spot treatment to selective surfaces, such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)

NON-FOOD AREAS — Including garbage rooms, lavatories, floor drains (to sewers) entries and vestibules, offices, locker rooms, machine fooms, boiler rooms, garages, mop closets and storage (after canning for bottling). Apply to baseboard areas, around water pipes, surfaces /behind and beneath sinks, lockers, tables, pallets and similar areas twhere insects hide or through which they may enter. Repeat treatment as renuired.


