**SELECTION OF TREATMENT AREAS**  
Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Protect bait from rain or snow. Remove as much food as possible.

EATON'S® All-Weather BAIT BLOCKS® Rodenticide contains selected inert ingredients and 2 anti-coagulants blended into a ready-to-use palatable rodenticide that is lethal to rats when consumed over a period of several days.

**SUGGESTED USE**  
For use in wet or damp areas, snap off EATON'S® All-Weather BAIT BLOCKS® Rodenticide into the handy marked squares and place into protected areas where rats or mice are known to feed, water or exist.

**APPLICATION DIRECTIONS**  
**NORWAY RATS AND ROOF RATS:** Apply 2 to 8 squares (4 to 16 oz.) of bait per placement. Place bait at 15 to 30 foot intervals. Maintain an uninterrupted supply of fresh bait for at least 10 days.

**MICE:** Break each 2 oz. square into four or more pieces. Place bait at 8 to 12-foot intervals. Use one-fourth to one-half of a broken square at each placement site for light to moderate infestations. Where mouse activity is extremely high, the material from one broken square should be placed at each placement site. Larger placement (up to 2 oz.) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

**RATS & MICE:** Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and unconsumed bait properly. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.
