1. The qualifying statement that you proposed to use for the 8-ounce and 12-ounce containers is one that was developed for 4-ounce containers. The statement that should be used for the 8-ounce container is:

"The amount of bait in this package is unlikely to be sufficient to kill more than two to seven rats."

For the 12-ounce container, the qualifying statement should be:

"The amount of bait in this package is unlikely to be sufficient to kill more than three to nine rats."

2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
