Purpose	The purpose of this resubmission is to revise your label, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), in accordance with our letter of August 7, 2003,.
Label	The labeling submitted with the above letter, is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following changes, before you ship your product.
	1. The following text, which you currently have placed under "First Aid", belongs under "Note to Physician":
	If swallowed: This material may reduce the clotting ability of the blood and cause bleeding.
	Your "First Aid" text must contain a statement that one have the label when seeking treatment advice. To correct these problems, follow Enclosure 1.
	2. As indicated in both our letter and your reply, delete this sentence:
	The efficacy of this product may be reduced under high moisture conditions.

READ THIS LABEL. Read this entire label and follow all use directions and use precautions. IMPORTANT: Do not expose children, pets, or other nontarget animals to rodemicides. To help prevent accidents observe and follow these (3) instructions: 1. Store product not in use, in a location out of reach of children and pets.

2. Apply bait in locations out of reach of children, pets, domestic animals, and nontarget wildlife or in "temper-resistant" bait stations These statione must be resistant to destruction by dogs and by children under six years of age and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. 

SELECTION OF TREATMENT AREAS Determine areas where rats or mice will most likely find and consume the balt. For Rats: For the 8 oz.size: This package contains enough bait to kill two (2) to seven (7) rats.
 For the 12 oz. size: This package contains enough bait to kill three (3) to seven (7) rats.
 Apply 2 to 8 blocks (4 to 16 oz. of bait) per plecement. Maintain an uninterrupted supply of fresh bait for at least 10 days.
 For Mice: While wearing waterproof gloves break each 2 oz. block into 3 pleces and plece 1 or 2 pleces at 8 to 12 foot intervels. Larger placements (up to 3 pleces (2 oz.) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.
 <u>Follow up:</u> Replace contaminated or spoiled bait Immediately. Collect and dispose of all dead animals and any left-over bait property. To prevent reinfestation, limit sources of rodent food, water, and harborages as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish with fresh bait as often as needed.
