The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the changes listed below.

The comments immediately below apply to the typed outer-container label, submitted on June 27, 1995, as part of your proposed labeling for transforming this product into a mouse-only, 1.5-oz. feeder-box product.

1. The content and organization of the "DIRECTIONS FOR USE" on the typed outer-container label are acceptable.
2. On the front panel of the label, delete the quotation marks from "FOR INDOOR USE ONLY."
3. The outer-container label would not appear to apply to 1.5-oz. feeder boxes sold individually unless individual feeder boxes were to be placed within outer containers.

The comments immediately below apply to the printed 1.5-oz. feeder-box label, submitted on June 27, 1995.

1. Center the heading "DIRECTIONS FOR USE" on the back panel of the label and provide spaces between paragraphs as indicated in the Agency letter to you dated June 21, 1995.

2. The subheadings ("~~USE RESTRICTIONS~~", "~~SELECTION OF TREATMENT AREAS~~", AND "APPLICATION DIRECTIONS") are clearly subordinate to the main heading "DIRECTIONS FOR USE."

3. The type size and placement of "For Indoor Use Only" on the front panel is acceptable, but we would prefer that it be presented in all upper-case letters. Do not make this phrase any smaller than it appears on the feeder-box label that you submitted on June 27, 1995.

From past discussions with you, we have gotten the impression that the bait within the feeder-box is to be held within a plastic bag which would not be expected to be opened until it is attacked by animals seeking the bait. Please inform us if we are at all mistaken concerning the intended packaging of this product.

A completed report of the feeder-box penetration study with house mice is due by or before March 21, 1996.

Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

THIS IS NOT A TAMPER-PROOF OR TAMPER-RESISTANT BAIT STATION. DO NOT USE THIS PRODUCT IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS, OR NONTARGET WILDLIFE. DO NOT USE THIS PRODUCT OUTDOORS.

This product may be used to control house mice (Mus musculus) in homes, and in industrial, commercial, or agricultural buildings. Do not place feeder boxes in areas where there is a possibility of contaminating food, water, or surfaces that come in direct contact with either.

SELECTION OF TREATMENT AREAS

Determine areas where mice will most likely find and consume bait. Generally, these are along walls, by gnawed openings, beside burrows, or in corners and concealed places.

APPLICATION DIRECTIONS

Place single feeder boxes at intervals of 8- to 12- feet along walls or in corners where mice or signs of mice have been seen.

Replace feeder boxes if their contents have been consumed or contaminated, or if the units are severely damaged. Units not touched after three days should be moved to new locations where mouse activity is evident and units can be placed without violating the requirements of this label.

Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.
