**TOMATO/VEGETABLE ROSE & FLORAL DUST**

**USE AS A DUST:** Invert container and puff contents out of the perforated cap to leave a thin dust film directly onto foliage, stems, fruit and vegetables, hitting as many insects as possible with the dust. As a general rule apply 1 pound of dust to treat average 2 to 3 feet high plants growing in a 20 x 25 sq. ft. area; (500 sq. ft.). This product can be used for control of the following insects that may attack the list of vegetables and/or flowers. Repeat as needed for continued control.
