2. Modify the proposed label submitted on April 26, 1996 as indicated below before you release the product for shipment.
- a. Revise the EPA Registration Number to read, "EPA Reg. No. 56-71.
 - b. Revise the text under "**PRECAUTIONARY STATEMENTS**" to read as follows:

"CAUTION: Keep away from humans, domestic animals, and pets. May be harmful or fatal if swallowed or absorbed through the skin. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling bait.

NOTE TO PHYSICIAN: If swallowed or absorbed through the skin, this material may reduce the clotting ability of the blood and cause bleeding. If ingested, administer Vitamin K₁ intramuscularly or orally, as indicated in bishydroxycoumarin overdoses. Repeat as necessary based on monitoring of prothrombin times."
 - c. Below the "**NOTE TO PHYSICIAN**" section, add an emergency telephone number to call for specialized medical advice.
 - d. The "**DIRECTIONS FOR USE**" portion of the proposed label is acceptable. Keep the proposed organizational format when you print final labels.
 - e. The proposed modified single-feeding claim is acceptable at this time but will be reassessed during product reregistration.
 - f. On the last page of your proposed label, delete the statement "**NO PREBAITING REQUIRED.**"

Prebaiting is placement of bait without toxicant prior to application of toxic bait to increase acceptance by target animals. The appearance of this text on the label is unnecessary and confusing and should be deleted from the label for the following reasons:

1. The average person and many pest control operators are

not familiar with the term "prebaiting."

- 2. There are no commensal rodenticides that require prebaiting.
- g. Also on the last page of your proposed label, delete the statement "JUST USE AS DIRECTED."

Since there is already a label statement concerning misuse in the "DIRECTIONS FOR USE" section, this statement is redundant.

- 3. Submit two copies of your revised final printed label before you release the product for shipment.

If the above specified conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

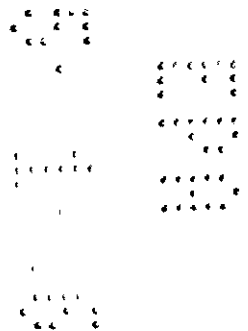

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, other potentially destructive animals, or in areas prone to vandalism.

3. Dispose of product container, and unused, spoiled, and unconsumed bait as specified on this label.

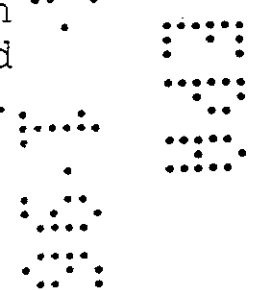
USE RESTRICTIONS : For control of Norway Rats, Roof Rats and house mice in and around homes, industrial and agricultural buildings, and similar man-made structures. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats and mice will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow. Remove as much food as possible.

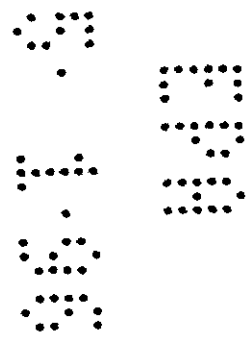
APPLICATION DIRECTIONS:

Rats: Apply 4 to 16 oz. of bait per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days.

Mice: Apply 1/4 to 1/2 oz. of bait at 8- to 12- foot intervals. Larger placements (up to 2 oz. may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.



Rats and Mice: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store only in original container, in a cool, dry place inaccessible to children and pets.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

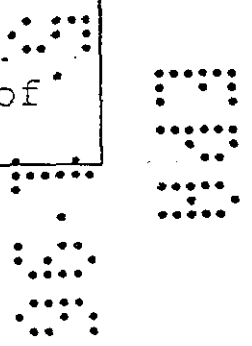
