Expar Insecticide/Repellent For Dogs and Horses kills and repels house flies, stable flies, horn flies, face flies, horse flies, deer flies, mosquitoes, gnats, cockroaches, silverfish and spiders. Expar Insecticide/Repellent for Dogs and Horses kills fleas, lice and ticks. Kills and repels flies for 3-5 days.

SHAKE WELL BEFORE USING

**DIRECTIONS FOR SPRAY:** First, remove excess dirt and dust by brushing. Apply spray to animal paying special attention to legs, shoulders, and neck. For head and eye area, dampen an applicator mitt, cloth or toweling (Turkish) with Expar Insecticide/Repellent For Dogs and Horses and wipe over face. Be especially careful not to get in eyes. Do not soak hair or skin. Repeat as necessary.

**DIRECTIONS FOR WIPE-ON:** First, remove excess dirt and dust by brushing. Dampen an applicator mitt, cloth or toweling (Turkish) with Expar Insecticide/Repellent For Dogs and Horses. Rub over hair with special attention to the legs, shoulders, neck and facial areas where flies tend to congregate. Be especially careful not to get in eyes. Repeat as necessary.

**DIRECTIONS FOR GENERAL SURFACE SPRAY:** Spray infested areas such as pet beds and resting areas, and areas of floor covering (such as carpeting) where pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment.

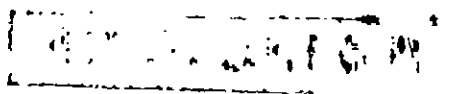
