DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ ALL DIRECTIONS COMPLETELY BEFORE USE.

For use in homes, apartments, attics, basements, garages, pets' sleeping areas, kennels, etc. For most effective results, entire dwelling should be treated. Use one fogger for each 10,000 cu. ft. (or 1,250 sq. ft.) of unobstructed area. Use additional units for remote rooms or where the free flow of mist is not assured. Do not use this product in or on electrical equipment due to possibility of shock hazard.

Preparation: Close exterior doors and windows. Shut off fans and air conditioners. Open interior doors, cabinets and closets of areas to be treated. Put out all open flames except pilot lights. Remove pets and birds but leave pets' bedding. Cover or remove fish tanks and bowls. Remove or cover plastic items such as stereo covers, notion boxes or eyeglasses. Leave rugs, drapes and upholstered furniture in place. This product will not harm furniture when used as directed.

Cover exposed foods, dishes and food handling equipment.

To start fogging: Make sure all preparation steps have been completed. Locate fogger in the center of the space to be treated. Fogger should not be placed within six feet of a pilot light. Place fogger on a raised platform, such as a table or stool with several layers of newspaper covering the area directly under the can. Hold the can at arm's length, pointing the top away from face and eyes. Do not aim directly at furniture. Press down the actuator to lock into position—this will start fogging action. Replace fogger in upright position onto newspapers and leave the treated area at once. **DO NOT RE-ENTER AREA FOR TWO HOURS.** After two hours, open doors and windows, turn on air conditioners and fans and let area ventilate for 30 minutes. All food processing surfaces should be thoroughly cleaned before using.

To protect pets from fleas and ticks, use other Coopers products for pest control on dogs and cats.
