We have reviewed the data waiver requested for all acute toxicity studied and agree that the data may be waived based upon availability of acute toxicity data for similar products you identified in your application. 3. Make the labeling changes listed below before you release the product for shipment:

a. Add the phrase "EPA Registration No. 59-243

b. Under If on skin: change "Get medical attention if irritation persists" to "Get medical attention."

c. Under HAZARDS TO HUMANS AND DOMESTIC ANIMALS change "Avoid contact with eyes." to "Harmful if absorbed through skin. Avoid contact with skin, eyes and clothing. Wash thoroughly with soap and water after handling. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."

d. Add the statement about using this product in an integrated pest management system similar to the statement on product label Atoban Delice Plus Insecticide (EPA Registration Number 59-229).

e. Delete the phrase "non-systemic" on the front panel.

4. Submit two (2) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.
