

## DIRECTIONS

**MARVEL SPRAY** can be brushed on or sprayed as a coarse spray. Cover cracks and areas such as window sills, floors, moldings, water pipes, and the natural habitation and hiding places of insect pests.

**ROACHES OR WATERBUGS:** Liberally treat infested cracks and other hiding places. Apply locally on exposed surfaces where insects will crawl when they come out of hiding. Repeat treatment whenever reinfestation occurs.

**ANTS:** Apply thoroughly to ant trails and areas around window frames and door sills where ants enter. Treat openings around pipes, baseboards and other outlets where ants may get into premises. Repeat if necessary to get effective control.

**SILVERFISH:** Apply thoroughly to infested cracks, and other infested hiding places such as storage areas, behind shelving, and around and on bookshelves.

**CARPET BEETLES:** Work the material thoroughly into cracks and cover areas of the floor, baseboards, and closet shelves and under carpets where these pests may be found.

**BROWN DOG TICKS in premises:** Treat liberally infested cracks and hiding places around baseboards, window and door frames, sleeping areas of household pets, and local areas on floors and floor coverings. Place fresh bedding in animal quarters after treatment. **Do not treat pets or other animals.**  
**To Control BOX ELDER BUGS:** Paint or spray on doorsills and window frames where pests enter. Spray insects directly wherever observed. Spraying porches, house siding etc., will aid in controlling these pests.

**To Control FLIES AND MOSQUITOES:** Brush or spray selected surfaces of walls, ceilings, door and window sills where these insects tend to congregate.

## CAUTION

Do not use near open flame. Repeated or prolonged contact with the skin can cause toxic symptoms. Avoid inhalation and skin contact. **DO NOT USE ON HOUSEHOLD PETS OR HUMANS. HARMFUL IF SWALLOWED. KEEP OUT OF REACH OF CHILDREN.** Avoid contamination of foodstuffs. Do not use on vegetation. **AVOID WETTING RUBBER, ASPHALT, PLASTIC,** or other materials affected by petroleum. **DO NOT** smoke while spraying.
