CAUTION

Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

Remove birds and cover fish bowls when spraying. Avoid excessive wetting of plastic vinyl or asphalt tile floor surfaces.

Environmental Hazards

This pesticide is toxic to fish, birds, and aquatic invertebrates. Do not apply directly to water or wetlands (swamps, marshes, bogs, and potholes). Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water by cleaning of equipment or disposal of wastes. This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area.

Directions for Use

DIRECTIONS:

ROACHES, RESISTANT ROACHES, WATERBUGS, CRICKETS AND CENTIPEDES. Thoroughly spray cracks, crevices, baseboards, underneath chairs, tables, kitchen shelves, cupboards, sinks, refrigerators, around garbage containers and other similar places where insects may habitate.

ANTS. Spray ant trails, door sills, around window frames and other places where ants may enter. Spray directly on ant hills. Spray directly on swarming ants out doors, only.

CLOVER MITES, SOWBUGS AND EARWIGS. Spray around window frames and other points of entry. Apply to outside foundation and porches to ground level.

FLIES, MOSQUITOES, GNATS, WASPS. Apply on screens, walls, doors and around window frames, light fixtures and other outdoor surfaces where insects congregate.

PAPER NEST WASPS AND MUD DAUBERS. Apply a wet spray to the nests after dark when all pests have returned to their nests.

SCORPIONS, SPIDERS. Spray directly on pests when possible. Treat surfaces of garages and out-buildings where pests hide up congregate. Spray points of entry such as around window frames and along crevices.

SILVERFISH, FIREBRATS. Apply to cracks, baseboards, behind shelving, bookcases and other stolage areas.

BROWN DOG TICKS. Thoroughly spray cracks, crevices and areas where pets normally lie down. Do not spray on pets, Allow the sprayed areas to dry thoroughly. Replace bedding before permitting use by animals. For dog kennels, apply to outside runways and around window frames.

STORAGE AND DISPOSAL

Store in original container. Store and use at room temperature. Do not expose to heat or direct sunlight. Do not reuse empty container. Wrap container and put in trash.
