  - On the placepack label, delete the non-household STORAGE AND DISPOSAL instructions. Household STORAGE AND DISPOSAL instructions are sufficient for the 4-oz. placepack.

Under "Disposa": ", change ". . . empty container." to ". . . empty pack." (or, ". . . empty bags.", if you prefer referring to the package as a bag rather than a pack]

- On the pail container label, delete the sentence "Container may be reused for non-food or feed purposes if thoroughly cleaned." from the "Container Disposal:" instructions. This sentence does not comply with the container disposal instructions specified in PK Notice 83-3.
- On both the placepack and pail labels, change ". . . atleast 15 days." to ". . . at least 15 days." in the last sentence under the APPLICATION DIRECTIONS for "MICE:".

IMPORTANT: Do not expose children, pets, or other nontarget animals to codenticities.

To help to prevent accidents:

1) Store product not in use in a location out of reach of children and pets.

- 2) Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. MICE: Open placepack and apply 1/4 to 1/2 oz. (1-2 level tablespoons) of bait at 8 to 12 foot intervals. Larger placements (up to 2 oz.) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for atleast 15 days.

RATS/MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

## STORAGE AND DISPOSAL (8 pt)

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in original container in a cool, dry location inaccessible to children and pets.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Dispose of empty container in a sanitary landfill of by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke. Container may be reused for non-food or feed purposes if thoroughly cleaned.
