Place 1 to 4 Kill-Ko Thro Pac next to burrows in runways or where rats are accustomed to feeding. Check these treated bait stations daily to assure an uninterrupted supply of bait for not less than 12 days. Continue baiting until all signs of feeding have stopped.

Stale, damp or moldy bait should be replaced with fresh bait promptly. Treated bait must be placed at locations not accessible to children, pets, wildlife and domestic animals or in tamper-proof bait boxes. One Kill-Ko Thro Pac contains adequate bait for one or two rats.

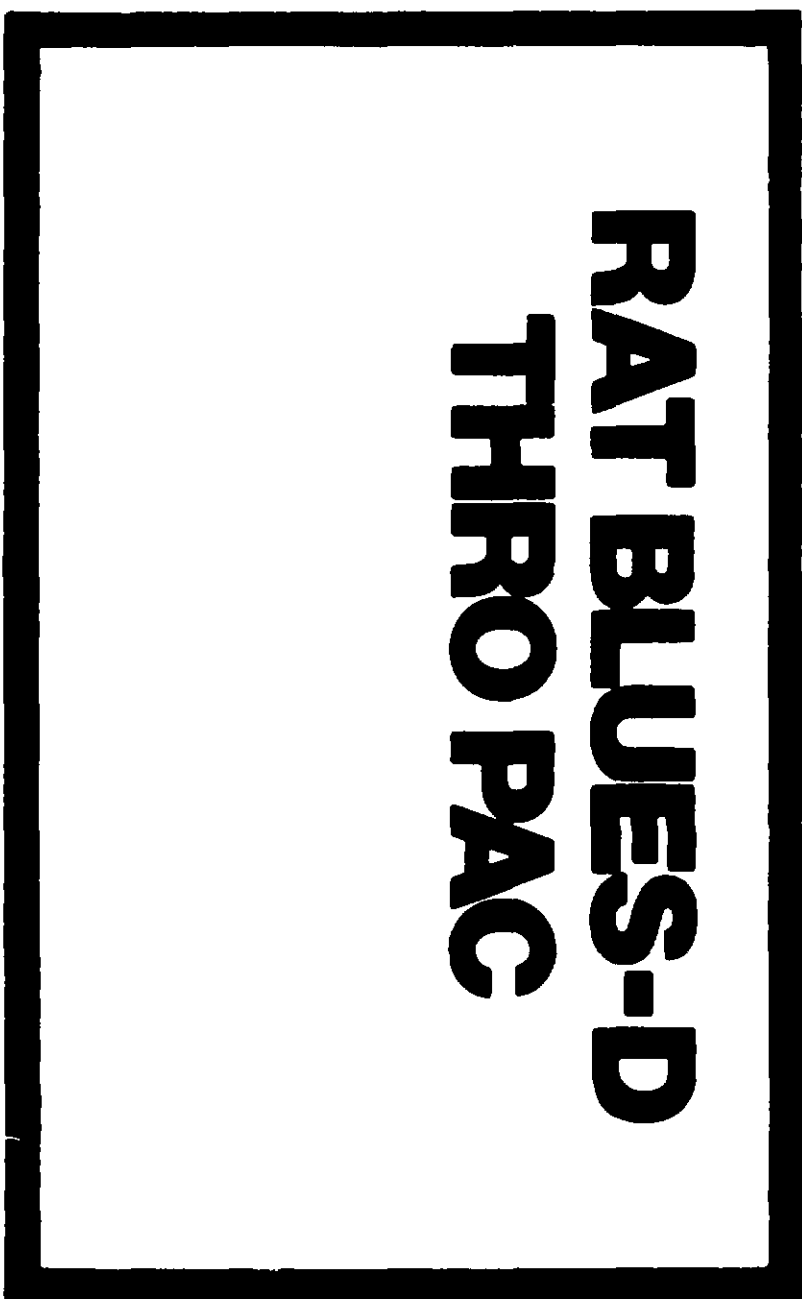
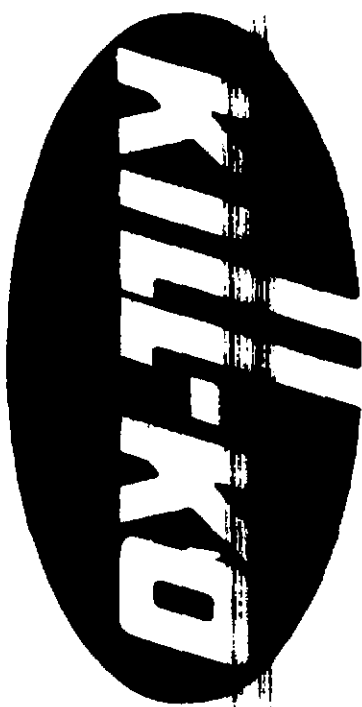
