1. Make the following changes to your label:

A: 170 244.1 115/94

a) Because your product is a bait instead of a dust, please modify the following statements to provide more appropriate instructions for a granular product:

1. In the Environmental Hazards Statement, change "Before spraying, warn beekeepers..." to "Before application, warn beekeepers..."

2. In the Directions for Use, change the paragraph "Wearing household latex or rubber gloves..." to

"Wearing household latex or rubber gloves, use a shaker can or rotary type applicator. Apply when air is calm to avoid drift and contact with eyes and skin. Start applying at the farthest corner of the treatment area and work backward to avoid contact with treated surfaces. Allow any dust to settle in treated areas before reentering. For plants above chest height, consider using a liquid carbaryl product. Do not repeat application more than once a week."
