

To Kill Fleas, Dog Ticks and Flies: Apply as a spot treatment on infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind lardboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do Not Spray Pets With This Product.

For Crack and Crevice:

To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas, and Carpet Beetles: Apply diluted spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where the above listed insects hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

Flies and Mosquitoes: Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surface will be killed. Repeat treatment when necessary.

STORAGE AND DISPOSAL

Storage: Store in a cool dry area away from heat or open flame.

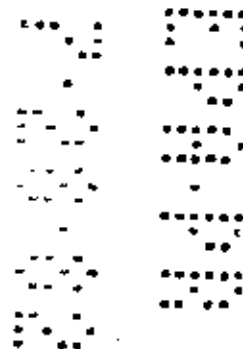
