

Only for formulation into a herbicide for the following uses: 1) terrestrial outdoor non-food uses, including residential lawns, sod farms, ornamental turf, golf courses, parks and playgrounds, cemeteries, rights-of-ways, commercial, industrial or athletic turf; 2) uses for which U.S. EPA has accepted the required data or citations of data that the formulator has submitted in support of registration; and 3) uses for experimental purposes that are in compliance with U.S. EPA requirements. Formulators should consult Hyponex Corporation before using this product. Each formulator is responsible for obtaining EPA registration for their end-use product(s).

(For containers greater than 5 gallons). Empty the remaining contents into a storage container or a mix tank. Fill the container $\frac{1}{4}$ full with appropriate solvent ⁽¹⁾. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Cleaning the container before final disposal is the responsibility of the person disposing of the container. Offer for recycling if available, or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Do not cut or weld metal containers.

OR

(For containers 5 gallons or less). Empty the remaining contents into storage container or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container $\frac{1}{4}$ full with appropriate solvent ⁽¹⁾ and recap. Shake for 10 seconds. Pour rinsate into storage container or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available, or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Do not cut or weld metal containers.

OR

[Returnable/Refillable Containers:]

Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents into a storage container or mix tank. Triple rinse as follows: Fill the container 10% full with appropriate solvent ⁽¹⁾. Agitate vigorously or recirculate solvent with a pump for two minutes. Pour or pump rinsate into storage container or rinsate collection system. Repeat this rinsing procedure two more times. Then offer for recycling if available, or reconditioning or puncture or dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. (¹) An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards, and regulations.
