STATEMENT OF PRACTICAL TREATMENT

If swallowed call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person. If on skin, wash affected areas with soap and water. If in eyes, flush with plenty of water.
