## DIRECTIONS FOR USE

GRAIN KEEP is a product to be used for the control of mold and fungi on corn and milo for animal feed. Use Grain Keep on corn and mile with a moisture content of 26% maximum. Do not use this product on corn and mile which may be used for seed, malting or human consumption.

## MANAGEMENT OF HIGH MOISTURE CORN AND MILO WITH GRAIN KEEP:

- 1. Remove all leaf and stem particles from corn and milo before storing.
- 2. Treat and store only whole kernels. (Not cracked or ground corn or milo.)
- 3. Clean all storage buildings and harvesting machinery of old grain and dirt.
- 4. Line metal and concrete bins with plastic. Cover concrete floors with plastic.
- 5. Treat all high moisture corn and milo with GRAIN KEEP. Make sure equipment is functioning properly before treating corn or milo. Uniform treatment is important.
- 6. If improper application has been made, corn or milo will heat. If heating occurs, remove grain from the bin and dry.

**DIRECTIONS:** Use GRAIN KEEP at the rate of 12.5 lbs. or 12.5 pints per ton of corn or mile with a maximum moir are of 26% to protect corn or milo for six months storage. For one year protection use 19 lbs. or 19 pints per ton of corn or milo. GRAIN KEEP must be applied in the form of a spray. Treat corn or milo within 12 hours (maximum) after harvest.

**CAUTION:** At temperatures below 20°F., equipment and liquid should be kept warm to maintain adequate application rates.

Treating and storing corn or milo at higher moisture levels or treating with less than the recommended amount of GRAIN KEEP may result in heating and molding.
