The labeling referred to above, submitted in connection with a registration under the Federal Insecticide, Fungicide, and Rodenticide Act is acceptable and a stamped copy of the contained and booklet label is enclosed for your records.

Please make the following revision when preparing the actual finished label (or finished customer guide label):

- 1) On both the container and booklet label, modify the home use limitation to read "For outdoor use on the home lawn and the home garden only.". You will note that the preferred location for the word "only" is at the end of the limitation, as indicated in our previous letter, dated February 14, 1992. Deleting the word "in" from "in the home garden" would appear appropriate since this product can be applied foliarly (i.e., on vegetable and ornamental plants) as opposed to the granular products which are only applied "in" the garden (i.e., soil incorporated). Also, such a revision eliminates any possible user misunderstanding of the limitation stating "..in the home..", while item "2" of NOTES under the heading "General Information" specifies "Do not use in the home".
- 2) The Measurement Conversion table on page 4 of the booklet label would be more useful if it also included a conversion of the lawn rate: $1\frac{1}{2}$ Tablespoons in 3 gallons of water = $1\frac{1}{2}$ teaspoons

in 1 gallon of water. Most hose-end sprayers (which would be commonly used for overall lawn treatment) require the user to know the amount of product to be diluted in one gallon of water to be able to determine the amount of product to add to the spray container. The Agency recommends deleting the conversion "or 6 ozs. in 18 gals. of water" for several reasons. First, most hose-end sprayers for foliar application deliver only 6 gallons of diluted product (pump sprayers are commonly available only up to 3 gallon capacity). While some lawn use hose-end sprayers may be capable of delivering 18 gallons of diluted product, the rate given in the conversion table is an extension of the 2 tablespoons in 3 gallons of water vegetable foliar spray rate, and is NOT the extension of the lawn rate of 1½ tablespoons in 3 gallons of water, which is 6 ozs. in 24 gallons of water.

- 3) Under the heading "Nuisance Pests Outside the Home", in the limitations appearing in the REMARKS for control of ants, brown dog ticks, and fleas etc., revise "Do not treat animals." to read "Do not treat animals with this product.". It may be appropriate for homeowners to also treat their pets with a suitable pesticide product registered for flea and tick control on pets.
- 4) Revise the first sentence of the fire ant control directions to read "To aid in the control of fire ants in home lawns and other outdoor home recreation areas, ".
- 5) The Agency has considered your April 28, 1992 request that the Note "Diazinon will not control organophosphate resistant leafminers" not appear on this products label. Organophosphate resistant leafminer populations do exist and the Agency feels it is appropriate to note this on the label. However, the Agency can see your point that the text as stated on diazinon agricultural use products may not be understood by some homeowners. Therefore, the Agency recommends that you modify the Note that will appear in the "Timing/Special Directions" for control of leafminers on various crops to read something like the following:

NOTE: Certain leafminers will not be controlled by diazinon or similar type insecticides.

6) Please note that the booklet label, as accepted, includes a revised page 12 (FAXed to the Agency May 12, 1992) and revised pages 16, 24, and 25 (submitted May 12, 1992). The container label, as accepted, includes a revised page 4 (submitted May 12, 1992).

The Confidential Statement of Formula (CSF) dated December 16, 1991 is acceptable and supersedes all previous CSFs for the subject product.
