#### **Turf and Lawn Nematodes**

For the control of plant-parasitic nematodes, including sting, lance, ring, spiral, stylet, sheath, sheathoid and pin in lawns and turf, apply Sarolex Nematicide-insecticide at the rate of 1½-2½ pts. in a minimum of 30 gals, of water per 1,000 sq. ft. Water lawn thoroughly (½-1 inch) as soon as possible after application.

#### Turf and Lawn Insects

The rates of Sarolex given for turf and lawn nematode control will give good control of the insects listed in the chart below. If Sarolex is used primarily for insect control, use the rates listed below

#### Statement of Practical Treatment
