

Brown dog ticks: Spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of pets, and localized areas of floors and floor coverings. Repeat as necessary. Fresh bedding should be placed in animal quarters after treatment. Do not treat animals.

Spiders: Apply spray around windows, doors, and along baseboards. Make spot applications to other areas over which these pests may crawl.

Surfaces behind and beneath cabinets: Roaches, ants, silverfish—as a supplement to good housekeeping, spray surfaces behind and beneath cabinets where insects tend to hide. Spray until wet. Remove all food before spraying. Infested food packages should be destroyed.

Flies, Mosquitoes, Wasps, Flying moths: For outdoor use only as an aid in reducing annoyance from these insects.
