## Precautionary Statements

#### DANGER

### Hazards to Humans and Domestic Animals

Fatal if swallowed, inhaled or absorbed through skin or eyes. Causes eye damage and skin irritation. Do not get in eyes, on skin or clothing. Do not breathe vapors. Use only in a well-ventilated area. Wear protective clothing including rubber gloves, a NIOSH approved pesticide mask or respirator such as a Comfo® II (MSA), and goggles or face shield when handling or mixing. If inhaled: move to fresh air. If not breathing, give artificial respiration, preferrably mouth-to-mouth unless exposure was from swallowing, then use other means. If breathing is difficult give oxygen. Get medical attention.

Note to Physician: Methidathion is a cholinesterase inhibitor. Atropine is antidotal and should be given as early poisoning symptoms appear. 2-PAM is also antidotal and may be administered in conjunction with atropine. If swallowed, lavage stomach taking care to avoid aspiration of stomach content: into lungs. Instill 30 to 50 gm. slurry of activated charcoal in water into the stomach after lavage.

### Environmental Hazards

This pesticide is toxic to fish and wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or public waters unless this product is specifically identified and addressed in an NPDES permit.
