

Precautionary Statements

DANGER

Hazards to Humans and Domestic Animals

Fatal if swallowed, inhaled or absorbed through skin or eyes. Causes eye damage and skin irritation. Do not get in eyes, on skin or clothing. Do not breathe vapors. Use only in a well-ventilated area. Wear protective clothing including rubber gloves, a respirator with either an organic vapor-removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C) or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G), and goggles or face shield when handling or mixing. Wash thoroughly with soap and water after handling and before eating, drinking or smoking. Remove contaminated clothing and wash before reuse. Do not contaminate food or feed.

Statement of Practical Treatment

If swallowed: immediately contact a physician or Poison Control Center. Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person.

If on skin: immediately remove contaminated clothing, wiping away excess material from skin. Wash with plenty of soap and water. Contact a physician or Poison Control Center.

If in eyes: flush eyes with plenty of water and get medical attention.

If inhaled: move to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth unless exposure was from swallowing, then use other means. If breathing is difficult give oxygen. Get medical attention.

Note to Physician: Methidathion is a cholinesterase inhibitor. Atropine is antidotal and should be given as early poisoning symptoms appear. 2-PAM is also antidotal and may be administered in conjunction with atropine. If swallowed, lavage stomach taking care to avoid aspiration of stomach contents into lungs. Instill 30 to 50 gm. slurry of activated charcoal in water into the stomach after lavage.

Environmental Hazards

This pesticide is toxic to fish and wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge.
