Storage and Disposal

Store in a dry place. Do not contaminate water, food, or feed by storage or disposal. Pesticide wastes may be toxic. Improper disposal of unused pesticide or rinsate is a violation of federal law. Completely empty bag into equipment. This is a reusable bag. If the container is to be refilled, do not rinse with any material or introduce any pesticide other than Technical Prometryn.
