This submission converts tolerances for the leafy petioles subgroup 4B to the newer leaf petiole vegetable subgroup 22B while establishing individual tolerances for Florence fennel, celtuce and Swiss chard; plus conversion of the current tolerance for cotton undelinted seed to the newer Cottonseed subgroup 20C
